The aim of Supercomputing Wales (SCW) is to facilitate, enhance and accelerate high quality research at the partner universities, allowing them to gain research income and collaborate with project partners. Supercomputing Wales is a consortium of four universities, coordinated by Cardiff University and provides high-performance computing (HPC) facilities to researchers.. The other consortium partners are: Aberystwyth University, Bangor University and Swansea University.

In relation to the information for users of the HPC system, Cardiff University is the Data Controller and is committed to protecting the rights of individuals in line with Data Protection legislation. We keep records of your usage of the HPC system based on our legitimate interest to ensure the system is used in line with our policies.

How we keep your data secure

Data Protection legislation requires us to keep your information secure. This means that your confidentiality will be respected, and all appropriate measures will be taken to prevent unauthorised access and disclosure. Only members of staff from consortium partners who need access to relevant personal data will be authorised to do so. Information about you in electronic form will be subject to password and other security restrictions, while paper files will be stored in secure areas with controlled access. Who we share your information with

As Supercomputing Wales is part-funded by the European Regional Development Fund (part of the EU Structural Funds 2014-2020 programme), we are obliged to report on our activities to the Welsh European Funding Office (WEFO). These reports will include data relating to the monitoring data laid out in the Structural Funds definitions and information requirements under the Eligibility rules and conditions for EU funds support. In addition, we may share the Welsh Government and with external evaluators contracted by Cardiff University on behalf of Supercomputing Wales to carry out independent external evaluation of the operation. All data is shared in accordance with data protection legislation. Any published findings of research and evaluation studies will not identify individual participants/enterprises.

How long we'll keep your information

The Supercomputing Wales consortium is obliged to retain records of activity funded by the European Regional Development Fund for at least two calendar years from 31 December

that follows the submission of the accounts to the EC in which the final eligible expenditure for the operation is included.
